This score will assist you in understanding your investment profile and will provide you with a list of suggested managed portfolios from BMO Insurance's universal life investment options. Once you have reviewed the suggested options, simply select the portfolio that you feel is best for you. If you require additional information about these portfolios, ask your advisor.


