

### Prestige is...

- Easy and automatic: Fees are reduced automatically when your client reaches one of the two eligibility thresholds. No action is required on your part.
- Accessible: Assets held in segregated funds, guaranteed interest funds (GIFs) and the high interest savings account (HISA) are all taken into account when determining eligibility for Prestige preferential pricing.
- Lucrative: Reduced management fees apply to all funds in the IAG SRP Classic Series 75/75 and 75/100 and to My Education+.
- Secure: If asset market values drop below one of the eligibility thresholds due to market downturns, clients continue to enjoy Prestige preferential pricing.
- Tax savvy: No yearly taxation on management fee reductions for non-registered investments. To see all the details, refer to the Eligibility Guide and FAQ.

### TWO WAYS TO QUALIFY

### Individually

When your client reaches the \$300,000 or \$500,000 eligibility threshold, Prestige pricing is applied automatically.

No action is required on your part.

#### Example

Amanda, 48 years old \$300,000

Prestige pricing, **level 300** applies automatically

### As a family grouping

If your clients don't qualify individually, they may qualify with a family grouping!

In a few simple clicks, you can pool your clients' assets with those of family members who reside at the same address to qualify for either eligibility threshold.

#### Example

Rachel, 39 years old \$280,000

Paul, 42 years old \$210,000

Eli, 18 years old \$10,000

Prestige pricing, **level 500** applies to all family members' contracts

Whether your clients qualify individually or as part of a family grouping, they can share Prestige with extended family members, regardless of asset level or place of residence.

### Family grouping example:

Jerome and Sandrine's case:

- Jerome and Sandrine each have two individual savings contracts with iA Financial Group
- Total market value of Jerome's contracts: \$185,000
- Total market value of Sandrine's contracts:
   \$160,000

Individually, neither Jerome nor Sandrine would qualify for Prestige because their contracts do not add up to either eligibility threshold.



With the help of his advisor, Jerome creates a Prestige grouping that includes Sandrine. They both enjoy the benefits of Prestige reduced management fees on all their contracts.

### Corporate grouping example

Matthew's case:

- Matthew has two individual savings contracts with iA Financial Group that total \$85,000
- Matthew is a shareholder in Company A, but is not an annuitant

Matthew does not qualify for Prestige on his own because his asset level is lower than either eligibility threshold. As a shareholder, but not an annuitant of Company A's contract, he cannot use the assets of the corporation's contract to qualify on an individual basis.



However, by creating a grouping, the assets in the contract owned by Company A, of which Matthew is a shareholder, can be included in the eligibility calculation for his Prestige grouping.
